

## EVALUATING NOVEL APPROACHES TO GP TRAINING EDUCATION

**What does the research involve?** This project involves participating in a brief pre-education evaluation survey, an education initiative for those involved in GP training (such as listening to podcasts, pre-webinar reading, a two-webinar activity with reinforcement/teaching occurring between the sessions, and/or joint teaching of GP supervisors/registrars) and a post-education evaluation survey. Participation in the education initiatives and surveys is voluntary and participants may complete more than one education initiative and corresponding evaluation. All responses are anonymous.

**Why were you chosen for this project?** You have been invited to participate as someone involved in GP training who registered to attend a GPSA webinar.

**Possible benefits and risks to participants.** The study will provide important information to assist the development of tailored education strategies and resources for those involved in GP training. Participation in education initiatives and/or evaluation surveys may cause discomfort. If you feel distressed, please speak to a friend, family member or your GP, or call Lifeline (13 11 14).

**Incentive to participate.** Participation in the study is eligible for CPD.

**Results.** Study results will be made available on the GPSA website and will inform the development of GP education and training resources. Resultant research will be available in project reports, presented at conferences, and submitted for peer-reviewed journal publication.

**Consenting to participate in the project and withdrawing from the research.** Consent to participate in the project will be assumed by your completing and submitting the survey/s online via SurveyMonkey. You have the right to withdraw from further participation at any stage, however it will not be possible to withdraw past responses.

**Confidentiality.** Data will be collected anonymously using SurveyMonkey and transferred to the research team over a secure HTTPS connection. Contact details for post-education surveys will be collected separately following the pre-education survey data. Pre and post survey data will be linked via a participant generated unique code. Personal information will be collected separately following the post-education survey to facilitate CPD credit, which will not be linked to survey data. Aggregate, anonymous survey data will be published via peer-reviewed papers and GPSA/GPRA reports.

**Storage of data.** Data related to this research will only be available to project team members. Electronic data files will be password-protected, retained for a minimum of five years and destroyed according to Monash University guidelines when no longer required.
